The mission of the programme is to reduce the negative impact of the automotive sector on climate and the environment by **developing and integrating zero emission vehicles** with their **charging and refuelling infrastructure** and with its **users**.

Safe Automated Driving


The mission of the programme is to **improve road safety** and make transport more sustainable through safe **connected automated vehicles** prepared for sharing.

Transport and Mobility Services

The mission of the programme is to **develop and test new innovative services** and transport solutions that contribute to **more efficient use** of vehicles and transport systems.

The aim of FFI Accelerate is to accelerate the pace of energy transition through strong and broad collaboration between relevant actors in an implementation and ecosystem perspective.

- Has the potential to reach implementation within a few years
- Has relevant results that can be scaled up in a national and international context
