DTs also serve as critical tools in achieving sustainability targets by monitoring environmental impacts, optimizing energy use, and reducing emissions.

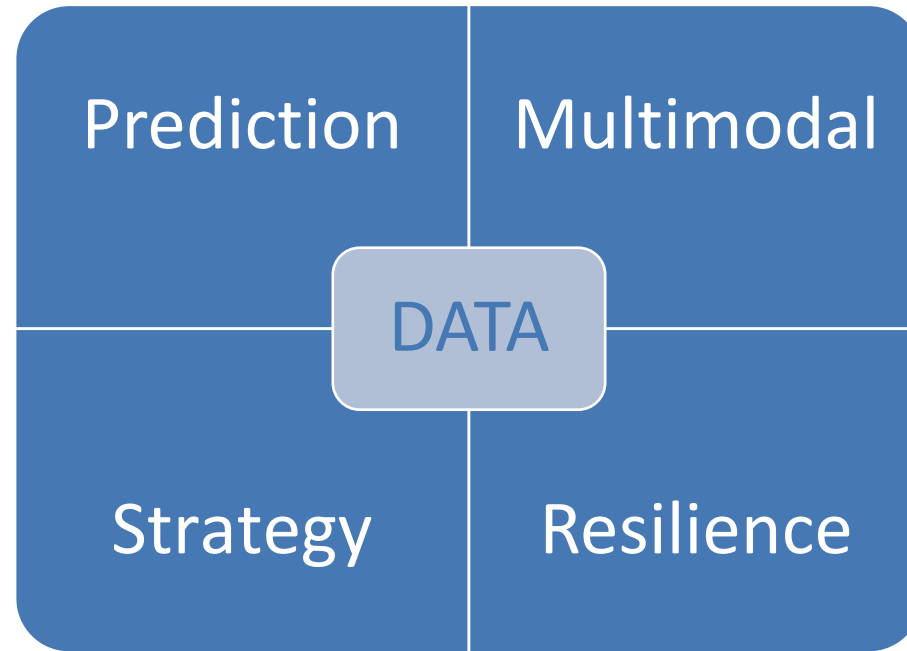
- **CRISTAL and MultiRELOAD are developing practical tools and pilots**
